- Nomination form may be presented in person by the candidate himself or by any person authorized by him in this behalf as per Election Programme.
- A regular Member who gets disqualified, under any of the provisions specified in section 43 & 44 of the Multi State Co-operative Societies Act 2002 & or Bye-Laws of the Bank, shall not be eligible for being nominated for a seat on the Board.
- The candidate filling the Nomination must comply prerequisites as per provisions of Bye- Laws of the Bank.
- The Candidate filling Nomination Form under the category of reserved seat for Scheduled Caste or Scheduled Tribe, should attach copy of caste certificate duly attested by Gazetted Officer / Notary with his Nomination Form.
- Withdrawal of Nomination (if any) shall be made by a Notice in writing by candidate himself and submitted in person by the candidate or by person authorized by him in this behalf as per Election Programme. A Notice of withdrawal of Nomination once given shall be irrevocable.
